2. Transportation costs to be assumed by Client (FOB STEWART's dock).

4. We do our best to source finished quality products. Certifications available upon request. Quality Checks are only performed on exterior packaging only for damage.
5. Claims for shortages must be made promptly (within 48 hours) after your receipt of the goods.
6. Issued purchase orders cannot be cancelled.
7. STEWART's invoice payment terms:
 - 50% down (must accompany Client's purchase order)
 - 50% due prior to shipment
8. All payments to be made via domestic wire transfer to STEWART's bank account (information to be provided upon execution of this agreement).
9. This quote is effective for 10 days.

In the event that STEWART is at any time unable to supply the product for any reason whatsoever, whether due to the failure of STEWART, manufacturer or other entity's or individuals in the supply chain to meet their ability to supply product or otherwise, such failure will be treated as a force majeure condition and Buyer's sole and exclusive remedy in respect of such supply failure shall be termination of this Agreement. In furtherance, and not in limitation of the foregoing, in no event shall STEWART be responsible under this Agreement for an inability to supply product resulting from a breach of the relevant purchase order(s).

STEWART shall not be liable for or bound in any manner by, and Buyer has not relied upon, any express or implied, oral or written information, warranty, guaranty, promise, statement, inducement or representation pertaining to the quality, usage and fitness of said product purchased from STEWART, except as is expressly set forth in this Agreement. STEWART shall not be liable for any injury, loss or damage, direct, indirect or consequential, arising out of the use or inability to use any product purchased or defects of same.
